RECEIPT OF STOCK

The depositor registered on the platform can bring their stock for storage in the warehouses. The process of receiving and issuing of the stored stock/commodity is explained in the upcoming steps.

(User – WHM)

1. Space Reservation

A. To store a stock under reservation basis, the depositor must have a reservation in the warehouse. To create a reservation request, the user will follow the below-mentioned steps:

Space Reservation >> Reservation request

- AS INDIVIDUAL:** AADHAR CARD/VOTER CARD/PAN CARD
- AS OTHER:** AADHAR CARD/VOTER CARD/PAN CARD

- B. The system will redirect the user to the above screen where the WHM will select if the reservation request is for a new user or an existing one.
- C. If the request is for a new user, then the warehouse manager will first register the user as a depositor (process mentioned in the Depositor Registration manual) and then proceed with the reservation request.
- D. If the request is for an existing depositor, then the user will click on the ‘Existing User’ button on the screen.

- E. The system will display the list of PAN India depositors. The WHM can search for the correct user from the search spaces provided and click on the ‘Next’ button.
- F. Once done, the system will ask the WHM for OTP verification. OTP is received on the registered mobile number of the depositor.

- G. The WHM can enter the OTP received by the depositor in the provided space or click on the ‘Resend OTP’ link (if the depositor did not receive an OTP).
- H. Once the OTP is entered, the WHM will click on the Verify button.
- a. If the OTP entered is incorrect, then the system will raise an error message for the same.
 - b. If the OTP matches, then the system will redirect the user to the reservation request screen.

- I. The WHM will enter the details requested in the screen and click on the ‘Next’ button to proceed ahead.
- J. The type of reservation requests one can make from this screen are:
- a. General Warehousing
 - b. Dedicated
 - c. Custom Bonded

Note: All the fields with ‘*’ sign are mandatory.

K. The WHM will select/enter the remaining fields in the form.

L. The WHM can perform the following actions on the screen.

- a. **Add new row:** Clicking on the ‘+’ button will add another row in the table. With this, the user can select multiple commodities in a single request.
- b. **Cancel:** Clicking on this button will cancel the whole process and redirect the user to the previous screen.
- c. **Submit:** Clicking on this request will submit the same for processing.

M. The WHM will raise a bill against the reservation request created. Once the bill is paid, the reservation request is complete.

2. Receipt of Stock

A depositor can store their goods under one of the storage facilities provided by the warehouses. The types of storages available in a warehouse are:

- Reservation Basis
- General Basis
- CMR

I. Reservation Basis

A. Create DAF

- a. To store a stock under reservation basis, the depositor will start with creating a DAF against the reservation request. To do so, the WHM will follow the below-mentioned steps:

- e. The WHM will enter the appropriate details in the form and submit the same.

Note: 1. All the fields with an ‘*’ sign are mandatory.

2. Declarations: ‘Said to weigh’ will exclude the weighment process and ‘Said to contain’ will exclude the quality process during the receipt of the said stock.

- f. Once submitted, the token will appear on the Gate-in screen where the warehouse can start receiving the stock. *(Note: The DAF is only valid for the day it was created. To receive stock on the next day, user will need to create another DAF)*

B. Gate-In

- a. After DAF, the token will show-up at the gate-in screen. To reach here user can follow the below mentioned steps.

- f. Clicking on the ‘Receipt gate-in’ button will redirect the user on the Gate-in Screen.

- b. The user will select the respective token from the dropdown and

click on the search button. (The token number sequence is: DDMMYY/Truck number/0001)

c. Once done, the weighment fields will pop for the selected token.

The user will enter the required details, i.e.,

- i. Weighbridge owner type (Own/Hired)
- ii. Packing
- iii. Weighment by (LWB/WCM)

1. LWB

a. Capture weight: The user can click on the 'Capture weight' button to auto-fetch the weight from the electronic weighbridge integrated or manually enter the weight in the provided space.

b. The weight thus captured is referred as gross weight (i.e., Stock weight + truck weight)

Note: On selection of 'LWB,' the weighment out is mandatory to calculate the net weight of the stock.

2. WCM

a. The user will first select the % for which they want to perform WCM, i.e., 10% or 100%.

b. Once selected, the appropriate number of rows will populate for the user to input correct weight of each bag.

c. The user will also enter the empty gunny weight for 2% of the stock to calculate the net weight of the stock.

Note: After WCM, weighment out is not required.

d. Once the appropriate information is fed in the form, the user will click on the submit button and proceed to the next step.

D. Quality Examination

a. After weighment-in, the token will show-up at the quality examination screen.

Note: The token will only come at the quality screen if the user left the 'Said to Contain' declaration unchecked on the DAF screen.

- c. The user will then proceed with selecting the quality type (Ministerial/Agmark) for quality examination. This will pop the refractions added for the respective commodity.
- d. The user will enter the details thus required and click on the submit

button to proceed ahead.

- a. After quality examination, the token will show-up at the Stacking screen.

- b. The user will select the respective token from the dropdown and click on the search button. (The token number sequence is: DDMMYY/Truck number/0001)
- c. Once done, the stacking fields will pop for the selected token.
- d. The user will then enter/select the required information in the form provided to perform the stacking. {The stack detail form will only come if there is a stack allocated for the respective commodity and depositor. If not, the system will ask the user to allocate a space.}
- e. The user can stack the commodity into multiple stacks, if required, by clicking on the ‘Add more’ button.
- f. Once done, the user will submit the details entered and proceed with the next step.

F. Weighment Out

- a. After stacking, the token will show-up at the Weighment-out screen.

- c. Once done, the weighment fields will pop for the selected token.
- d. The user will perform the weighment of the empty truck by clicking on the 'Capture weight' button and enter the weight of one empty gunny.
- e. The system will auto-calculate the net weight of the stock by the provided formula, i.e., Gross weight – Tare weight – (Empty gunny weight * number of bags)
- f. Once done, the user will submit the details and proceed ahead.

G. Gate-Out

- a. After Weighment-out, the token will show-up at the Gate-out screen.

- b. The user will select the respective token from the dropdown and click on the search button. (The token number sequence is: DDMMYY/Truck number/0001)
- c. Once done, the gate-out fields will pop for the selected token.
- d. The user will enter the required details and complete the receipt process.

H. ACK/WHR

- a. Once the receipt of the stock is complete, the user will proceed with generating and ACK/WHR for the stock received. The ACK serves as a proof of stock submission and is provided to the respective depositor.
- b. To reach this screen, the user will perform the below-mentioned steps:
 - Receipt of Stock >> Reservation Basis >> ACK/WHR**
- c. This will redirect the user to the WHR/ACK list screen where the user can search for the ACKs pending for generation. The user will select the Start date and End date to narrow down the search.
